PROPOSITION NO. 3 – Energy Performance Contract

Shall the following resolution be adopted?

RESOLVED, that (a) the Board of Education (the "Board") of the City School District of the City of Hornell (the "District"), is hereby specifically authorized by the voters of the District to undertake a particular energy performance improvements project (the "Project") pursuant to Article 9 of the Energy Law (such voter authorization not being necessary to allow the project to go forward, since such a project can be undertaken by the Board of Education acting on its own, but rather to allow the District to receive an extra 10% increment of building aid from the State of New York for such project), the cost of which is to be paid for from long-term energy cost savings that will be generated through certain conservation measures that are included and generally described in (but are not to be limited by) the RFP that was referred to in the public notice of the vote on this Proposition No.3, and to expend therefore an amount not to exceed \$3,000,000; (b) a tax is hereby voted in an amount not to exceed \$3,000,000 to finance the estimated maximum cost of the Project, such tax to be levied and collected in installments in such years and in such amounts as shall be determined by the Board; (c) in anticipation of such tax, obligations of the District are hereby authorized to be issued in the aggregate principal amount of not to exceed \$3,000,000, and a tax is hereby voted to pay the interest on such obligations as the same shall become due and payable; and (d) New York State Building Aid funds expected to be received by the District (in light of the energy cost savings expected to be
